PRIVACY POLICY

1. Scope of policy

This policy applies to www.finplifi.com, (hereinafter known as the Website). It regulates the processing of information relating to you and grants you various rights in respect of your personal data.

2. Definitions

- "We", "Our", and "Us", either in capital letters or not, shall mean and refer to the creators of this Privacy Policy, Finplifi Financial Planners and Consultants.
- ii. "You", "Your", "Yourself" and "User", either in capital letters or not, shall mean and refer to natural and legal entities that enter and/or use the Website, either to put up content or to view such content that has been put up.
- iii. "Personal Information" shall mean and refer to any personally identifiable information that We may collect from You. For removal of any doubts, please refer to Clause 3 below.
- iv. "Third Parties" refer to any application, Website, firm or individual apart from the User and the owner of the Website.

3. Information Collected

5. Use of information

- e. The right to lodge a complaint with a supervisory authority.
- f. The right to obtain information as to whether personal data are transferred to a third country or to an international organization.
